- The Government of the Republic of Liberia through the National Port Authority (NPA) has signed a Loan Agreement with Kuwait Fund for Arab Economic Development for assisting in the financing of the Port of Greenville Rehabilitation Project, Part of the proceeds of the Loan will be allocated toward the purchase one (1) new Log Loader under the contract IFB No. NPA/SP/KWLP/ICB/001/17/18.
